The Summer of 2022 I interned with the Henrico County's 4-H Youth development program located in the VCE Office. During this time I was able to learn more about extension and 4-H Youth Development. I learned that 4-H actually began in 1902 and its original purpose was to instruct rural youth with improved agriculture practices as well as homemaking practices. I worked under the 4-H Extension Agents. Mrs. Kendra Young is the Senior Extension Agent, 4-H Youth Development and Mrs. Carter Humphries is also an Extension Agent, 4-H Youth Development in the county. I spent a total of 400 hours with this department.

Henrico County's 4-H is focused on bringing research based information to the youth in the community. The mission statement of 4-H is to develop leadership, citizenship, and life skills. I was also informed that in the past year Henrico County 4-H had over 2,000 youth participate.

I was also able to attend events and programs with the Family & Consumer Sciences department led by the Extension Agent Kimberly Edmonds.
